Employee	Have you thought through how you will protect your employees in the workplace?	
Employee	Have you developed solutions for employees' "new" needs in this "new" workplace environment?	
Policies	Have you looked at expanding your remote work policies?	
Policies	Do you have updated safety, hand washing, and disinfecting policies and procedures?	
Policies	Do you have a "Social Distancing" Policy?	
Policies	Do you have a "Contact Tracing" Policy?	
Policies	Do you need to change your sick leave policies considering the 14 day quarantine guidance from the CDC?	
Policies	Have you taken into consideration how you will handle your work force's family demands if school is cancelled?	
Policies	Do you have an updated policy for furloughed employees?	
Policies	Do you have an updated travel policy? National? International?	
Policies	Do you have an updated technology usage policy for remote employees using company equipment?	
Operations	Have you reconsidered your policies on conferences or other meetings that involve large numbers of people?	
Operations	Have you considered changing cafeteria protocols/lunch catering?	
Operations	Are managers properly trained to manage remote workers?	
Operations	Are managers properly trained on infection outbreak protocols?	
Operations	Have you considered different work shift policies and approaches?	
Operations	Do you have critical/essential workers/roles identified that need to come back to the office?	
Operations	Have you identified who is able to remain in a remote working capacity?

Facilities	Have you increased hand washing and disinfecting stations?	
Facilities	Have you thought about automated doors and/or voice-activated elevators?	
Facilities	Have you reconsidered your outside delivery protocols and whether they need to change?	
Facilities	Have you reconsidered different cubicle/working space configurations (short-term and/or long-term)?	
Facilities	Have you reconsidered updating your HVAC/filtration system?	
Facilities	Have you updated your policy on visitors to the workplace? For instance: for guests, vendors, deliveries, etc.	
Facilities	Have you considered an Emergency Operations Center at a plant/branch level, not just at the corporate level?

Data/Analytics	Do you have new dashboards to keep up-to-date on critical metrics?	
Data/Analytics	Are you prepared to provide any new Federal/State reporting requirements that need to be maintained?

Supply Chain	Have you talked to your supply chain vendors to make sure they can meet your new needs?	
Supply Chain	Have you considered new supply chain vendors?
